Prior to leading the College Readiness Assessments division, Priscilla created and launched the College Board Opportunity Scholarships (now called the BigFuture Scholarships), a unique program that annually awards thousands of students with millions of dollars in scholarships simply for taking important college planning steps during high school. Prior to joining College Board, Priscilla was a Senior Vice President at the Poses Family Foundation. There she developed and managed Understood.org, the Webby-winning online resource for parents of children with learning and attention issues. Prior to leading Understood.org, Priscilla worked as a strategy consultant for large foundations and non-profit organizations at the Bridgespan Group. She began her career in investment banking and private equity.

Priscilla earned her MBA from the Harvard Business School and her bachelor's degree in finance and marketing from the University of Virginia. She lives in Washington, D.C. with her husband, two daughters, and dog.

As a former tenured professor of Quantitative Methodology and expert in Mathematics Education, she has partnered with teachers and leaders across the country to rethink and innovate the use of assessments in the formative process. Whether you're a teacher, leader, or someone curious about assessment innovation, this discussion invites you to explore how formative assessments can drive real-time learning, shaping both instruction and engagement for the benefit of all learners.

Dr. Laine Bradshaw is the Vice President of Classroom Solutions at Pearson. As a tenured associate professor of quantitative methodology in the College of Education at the University of Georgia (UGA), she created Navy, a student-friendly and learning-focused classroom assessment system, in close collaboration with educators. Navy leverages proprietary psychometric methods Dr. Bradshaw developed to give short yet reliable, on-demand assessments that celebrate learning achievements and pinpoint student needs. As an author, researcher, and edtech entrepreneur, Dr. Bradshaw was named among UGA's "40 under 40" alumni for 2021. She has received teaching, research, and community engagement awards from her university, and her scholarship has been recognized through awards from NCME and AERA. Dr. Bradshaw has a Ph.D. in research, evaluation, measurement, and statistics and an M.Ed. in mathematics education. She has published numerous peer-reviewed research articles in top journals on the topic of diagnostic psychometrics and formative assessment.

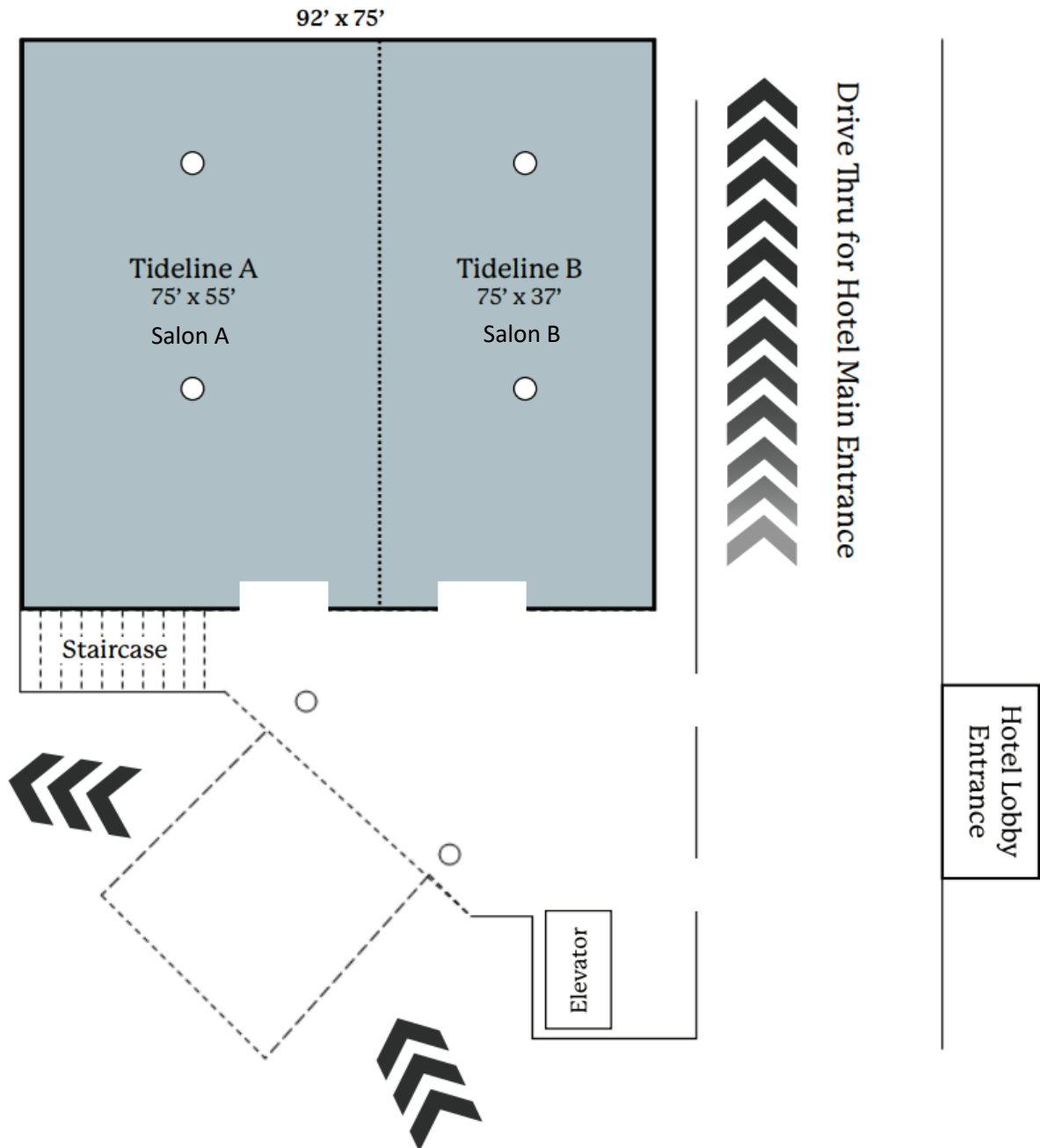

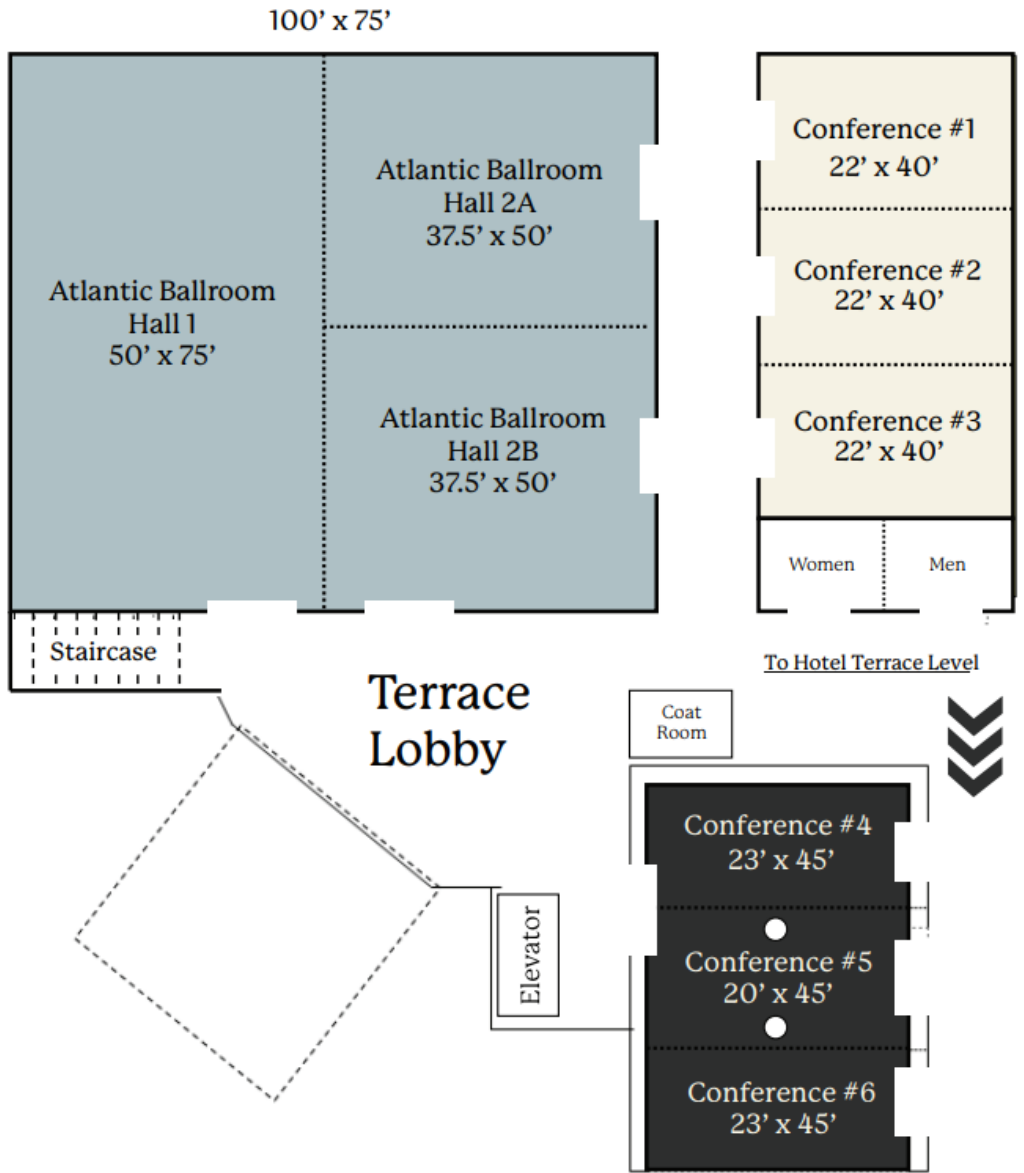
Floor Layout | First Level

Information about CDP/PDP credit

In August of 2024, the Maryland State Department of Education has significantly updated licensure requirements for Maryland educators. Educators are now required to work with their supervisor to develop [individualized professional development plans](#) (IPDPs) which encompass all the professional development activities the educator should traverse prior to renewing their license. For each activity completed, educators earn [professional development points](#) (PDPs), as opposed to CPD credits, for license renewals. PDPs are measured as follows:

- 1 clock hour is equivalent to one PDP.
- 1 semester hour of college credit is equivalent to 15 PDPs.
- One MSDE-approved Continuing Professional Development (CPD) credit is equivalent to 15 PDPs.
- One Continuing Education Unit (CEU) is equivalent to 10 PDPs.

Educators may accrue PDPs by completing any professional development activities described in [professional development points](#). The Maryland Assessment Conference offers the opportunity to earn credit by attending or presenting at a professional conference.

Individuals that complete the entire Maryland Assessment Group conference will receive a PDP certificate form at the conclusion of the Wednesday's Keynote address. The credit form that MAG provides, a copy of the program, and possible receipt for attendance should be all a participant needs (but this may vary by district). Some districts require PDPs to be entered into [TEACH](#) The Educator Application and Certification Hub.
